

## **“REECE & CAROMA FORMA” PROMOTION**

### **TERMS AND CONDITIONS**

1. Information on how to enter and the prize(s) form part of these Terms and Conditions. Participation in this promotion is deemed acceptance of these Terms and Conditions.
2. The Promotion is conducted by Caroma Industries Ltd. (ABN 35 000 189 499) of 7-9 Irvine Place Norwest Business Park Bella Vista, NSW, 2153, Australia, telephone: 13 14 16 (“Promoter”).
3. Participation in the Promotion is open to current Reece trading account holders or employees of account holders in Australia at any Reece Plumbing store nationally (each a “Participating Store”) aged 16 years and over (each an “Entrant”).
4. Entrants under 18 years old must have parental/guardian approval to enter and further, the parent/guardian of the entrant must read and consent to these Terms and Conditions. Parents/guardians may be required by the Promoter to enter into a further agreement as evidence of consent to the minor entering this promotion.
5. Employees (and their immediate families) of the Promoter or of Reece Group and agencies associated with this Promotion are ineligible to enter the Promotion. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1<sup>st</sup> cousin.
6. The Promotion commences on 01/02/2019 and closes at 11:59pm AEDT on 29/03/2019 (“**Promotional Period**”).
7. To be eligible to take part in the Promotion, an Entrant must Purchase any product from the Caroma Forma range in a Participating Store during the Promotional Period (“Eligible Transaction”). The Entrant’s Customer Code will then be automatically entered into the draw.
8. The Promoter reserves the right, at any time, to verify the validity of entries and Entrants (including an Entrant’s identity, age and place of residence) and reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter’s discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights. The Promoter’s legal rights to recover damages or other compensation from such an offender are reserved
9. Incomplete or indecipherable entries will be deemed invalid.
10. Multiple entries permitted, however only one (1) entry permitted per Entrant per Eligible Transaction.
11. If there is a dispute as to the identity of an Entrant, the Promoter reserves the right, in its sole discretion, to determine the identity of the Entrant.
12. The draw will take place at Anisimoff Legal, Suite 5, Erina Plaza, 210 Central Coast Highway Erina NSW 2250 at 3pm AEDT on 08/04/2019 in the presence of an independent scrutineer. The Promoter may draw additional reserve entries and record them in order in case an invalid entry or ineligible entrant is drawn. The winner will be notified by telephone and in writing within two (2) business days of the draw and their name will be published online at [www.reece.com.au](http://www.reece.com.au) from 10/04/2019 and in The Australian newspaper on 12/04/2019.
13. The Promoter’s decision is final and no correspondence will be entered into.

14. The first valid entry drawn will win their choice of a trip for two (2) adults to one (1) of the following three (3) destinations valued at up to \$8,000 depending on the trip chosen and point of departure:

- d. Three (3) nights' twin-share 4-star accommodation in Port Douglas, Queensland (including daily buffet breakfast;

- j. Three (3) nights' twin share 4-star accommodation in Margaret River (including buffet breakfast daily);

- l. Margaret River Canoe Tour for two(2) including lunch; and
- m. \$500 AUD spending money for the winner only (awarded via EFT transfer).

**Option 3 – Northern Territory Adventure – Prize Includes:**

- n. Two (2) x return economy airfares from winner's nearest capital city to Darwin, Northern Territory (for clarity, any ancillary costs associated with getting to and from the winner's departing airport will be the responsibility of the winner and his/her companion and are not included);
- o. All airline and airport taxes;
- p. Four (4) days' car hire with unlimited kilometres (either the winner or his/her companion must be aged 21 years or over and have a full driver's licence in order to redeem the car hire element of the prize);
- q. Three (3) nights' twin share 4-star accommodation in Darwin (including buffet breakfast daily);
- r. A choice of a Darwin City and Northern Beaches Scenic Helicopter Tour for two (2) or Freshwater or Saltwater Barrumundi Fishing Day Trip from Darwin for two (2);
- s. Jumping Crocodile Day Trip for two (2) from Darwin; and
- t. \$200 spending money for the winner only (awarded via EFT transfer).

15. For the removal of doubt, the winner can only choose one (1) of the above three (3) options.
16. Additional spending money, meals, taxes (excluding airline and airport taxes), insurance, transport to and from departure point, additional transfers, items of a personal nature, in-room charges and all other ancillary costs are not included. Winner and their companion must depart

Nothing in these Terms and Conditions limits, excludes or modifies or purports to limit, exclude or modify the statutory consumer guarantees as provided under the Competition and Consumer Act, as well as any other implied warranties under the ASIC Act or similar consumer protection laws in the States and Territories of Australia ("Non-Excludable Guarantees"). Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of the promotion.

Except for any liability that cannot by law be excluded, including the Non-Excludable Guarantees, the Promoter (including its respective officers, employees and agents) is not responsible for and excludes all liability (including negligence), for any personal injury; or any loss or damage (including loss of opportunity); whether direct, indirect, special or consequential, arising in any way out of: (a) any technical difficulties or equipment malfunction (whether or not under the Promoter's control); (b) any theft, unauthorised access or third party interference; (c)

any entry or prize claim that is late, lost, altered, damaged or misdirected (whether or not after their receipt by the Promoter) due to any reason beyond the reasonable control of the Promoter; (d) any variation in prize value to that stated in these Terms and Conditions; (e) any tax liability incurred by a winner or Entrant; (f) taking of the prize.

The Promoter collects personal information ("**PI**") in order to conduct the promotion and may, for this purpose, disclose such PI to third parties, including but not limited to Reece Pty Ltd, agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. The Privacy Policy also contains information about how Entrants may opt out, access, update or correct their PI, how Entrants may complain about a breach of the Australian Privacy Principles or any other applicable law and how those complaints will be dealt with. All entries become the property of the Promoter. The Promoter will not disclose PI to any entity outside of Australia.
