

## Reece's "Win a \$500 Reece voucher" Promotion

### TERMS AND CONDITIONS

1. Information on how to enter and the prize form part of these Terms and Conditions. Participation in Win a \$500 Reece voucher promotion ("Promotion") is deemed acceptance of these Terms and Conditions.
2. The Promoter is REECE AUSTRALIA PTY LTD (ABN 84 004 097 090).

### ELIGIBILITY

3. The Promotion is open to all Australian residents aged 18 and over.
4. Employees (and their immediate family and/or those living in the same household) of the Promoter, and its respective affiliates, subsidiaries, agencies and suppliers associated with this promotion are ineligible to enter. Immediate family means any of the following: spouse, ex-spouse, de-facto spouse, child or step-child (whether natural or by adoption), parent, step-parent, grandparent, step-grandparent, uncle, aunt, niece, nephew, brother, sister, step-brother, step-sister or 1st cousin.

### HOW TO ENTER

#### **DETERMINING AND NOTIFYING THE WINNER**

8. The draw will take place at the Australian office of the Promoter, 40 Oxford St, Collingwood, Melbourne at 10:00am AEST on Thursday 2nd July 2020. The Promoter will draw the winner at random from all eligible entrants.
9. One (1) entry will be selected for the Major Prize. The judge may select additional reserve entry, in case of an invalid entry or ineligible entrant.
10. The Promoter's decision is final and no correspondence will be entered into.

## GENERAL

16. Reece Bathrooms will be informed of the winning entry and the winner's details.

The Promoter reserves the right, in its sole discretion, to disqualify any individual who the Promoter has reason to believe has breached any of these Terms and Conditions, tampered with the entry process or engaged in any unlawful or other improper misconduct calculated to jeopardise the fair and proper conduct of the promotion. Errors and omissions may be accepted at the Promoter's discretion. Failure by the Promoter to enforce any of its rights at any stage does not constitute a waiver of those rights.

The Promoter collects personal information in order to conduct the promotion and may, for this purpose, disclose such information to third parties, including but not limited to agents, contractors, service providers, prize suppliers and, as required, to Australian regulatory authorities. Entry is conditional on providing this information. The Promoter may, for an indefinite period, unless otherwise advised, use this information, and disclose this information to third parties, including but not limited to Reece, for promotional, marketing, publicity, research and profiling purposes, including sending electronic messages or telephoning the entrant. Entrants should direct any request to opt out, access, update or correct personal information to the Promoter.
